WE SERVED AN ADDITIONAL 48 RIDERS OF ALL ABILITIES THROUGH OUR SEVEN WEEK-LONG SUMMER CAMPS. IN EACH OF OUR FORTY WEEKS OF REGULAR SESSIONS, LITTLE BIT SERVED 230 PATIENTS AND RIDERS, ASSISTED BY 350 VOLUNTEERS. LITTLE BIT HAS TWO MAIN PROGRAMS: EQUINE-ASSISTED THERAPY AND ADAPTIVE RIDING.

EQUINE-ASSISTED THERAPY IS AN INTENSIVE ONE-ON-ONE THERAPY SESSION WITH A LICENSED PHYSICAL, OCCUPATIONAL, OR SPEECH THERAPIST UTILIZING THE MOVEMENT OF THE HORSE AS A TREATMENT STRATEGY. THERE WERE A TOTAL OF
