## A Letter from Our Board Chair & Executive Director

As the first cases of COVID-19 were confirmed in Washington State, Little Bit staff immediately began planning next steps for the organization. When the Governor's "Stay at Home" order closed our doors on March 17 with no clear end date, our staff and community - the heartbeat of Little Bit - rallied to help continue to fulfill our mission.

There were horses to feed and exercise, bills to pay, staff to keep whole, riders and patients eager to return, and an entire community to keep safe and healthy. The Board of Trustees and staff leadership team worked together to ensure Little Bit remained on solid financial footing by trimming expenses, re-envisioning revenue and fundraising activities, and securing a federal PPP loan to take care of our employees - many with specialized and rare skill sets. In just over six short weeks our talented staff transformed the annual Reins of Life fundraising dinner and auction to a fully virtual event, exceeding our net budgeted amount for the event in partnership with our dedicated community.

In the face of uncertainty our resilient staff unleashed their ingenuity, adapting processes and procedures to rapidly evolving restrictions and guidance from federal and state healthcare agencies. As a result, not a single case of COVID-19 was transmitted at Little Bit. Therapy moved into a larger space in the Training Center and took on a whole new look. We welcomed back Therapy and Adaptive Riding program participants by training family members to serve as sidewalkers. The practice proved

so popular that we plan to continue it into the future. Summer camps with small groups and lots of space gave house-weary children fresh air, socialization, and beloved horse time.

The staff got creative with video chats, Facebook Live sessions, YouTube videos, and Zoom meetings to keep the Little Bit community connected and let everyone know we were safe and planning for the future. Survey results showed those efforts worked and respondents were grateful for the outreach.

Last year was indeed difficult. Thanks to our committed staff, volunteers, donors, and supporters, we overcame one of the greatest challenges of our lifetimes through persistence, confidence, good humor, and our sense of purpose—ensuring the future of Little Bit for the many, many riders and patients who depend on us. We are profoundly grateful for every one of you. Thank you!

# Together

## We Navigated the Challenges of COVID-19

Every part of the Little Bit organization has been impacted by the COVID-19 pandemic. The ever-devoted Little Bit community demonstrated its perseverance and resilience while meeting each challenge. The following changes took place:

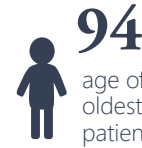
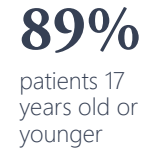
- Ceased programming from mid-March to mid-May 2020
- Increased communications across email and social media
- Trained all staff and volunteers in PPE usage and COVID safety protocols
- Installed outdoor handwashing stations
- Installed plexiglass dividers between tack barn stalls
- Added covers to tack whenever possible and carefully cleaned exposed tack surfaces and tools after each use
- Introduced limited use of virtual therapy sessions, as needed
- Increased unmounted therapy in the initial weeks of reopening
- Trained hundreds of patients' and riders' household members as sidewalkers
- Created 20 virtual lessons for participants, now posted at [littlebit.org/resources](http://littlebit.org/resources)
- Relocated in-room therapy space
- Developed additional outdoor therapy space
- Increased Therapy Program horse handler staffing to lessen possible cross contamination between departments
- Returned to typical Therapy Program service levels by end of 2020
- Reduced Adaptive Riding Program class sizes due to capacity and social distancing limits
- Staff members led horses in Adaptive Riding, transitioning back to volunteers in July 2020
- Transitioned three fundraising events to virtual formats
- Added new drive-through event for program families and volunteers

While the pandemic continued into 2021, the Little Bit community—patient and rider families, volunteers, Board of Trustees, staff, and donors—will long be remembered as being united with strength and passion behind the mission and all the families that we serve.



## Therapy

Hippotherapy is a physical, occupational, or speech-language therapy treatment strategy that utilizes equine movement combined with standard techniques and strategies as part of an integrated intervention program to achieve functional outcomes. The physical therapist focuses on skill areas related to gross motor ability such as, but not limited to, sitting, standing, and walking. The occupational therapist focuses on areas such as fine motor control, sensory integration, feeding skills, play skills, attention and self-regulation skills, and functional daily living skills. The speech-language pathologist focuses on respiratory function, breath control, oral-motor function targeting articulation, fluency, auditory processing, expressive language, receptive language, and social pragmatics.

# Adaptive Riding

Adaptive Riding is recreational horseback riding lessons for individuals with disabilities. The goals are riding-skill based; however, individuals and parents often report many therapeutic benefits of participation. Adaptive riding lessons are taught by instructors certified by the Professional Association of Therapeutic Horsemanship (PATH) International who create a wide variety of games and exercises designed to meet each student's needs. Classes include arena riding, trail rides, and group activities.

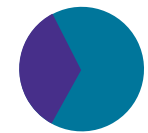

# Equine-Facilitated Psychotherapy

## Equine-Assisted Learning

Equine-Facilitated Psychotherapy (EFP) and Equine-Assisted Learning (EAL) involve Little Bit partnering with local mental health therapists (EFP) and educators (EAL) to provide services at our facility. Therapists and educators work hand in hand with a Little Bit staff equine specialist who is certified by the Professional Association of Therapeutic Horsemanship International. Horses are uniquely suited to these programs because they are intuitive and will react to behavior patterns and cues that people might miss, allowing the therapist or educator to interact on a deeper level with their patient or student and address issues that might otherwise go unnoticed.

*"My child was diagnosed with non-specific behavior, impulse control, conduct disorder, and also anxiety. . . . During our time at Little Bit, EFP has changed our lives. My child used to get so mad and hit me and throw fits, and I had a hard time physically getting them to cooperate. I did not have the tools to help my little child and I knew they had very big feelings to process. EFP gave my child a chance to connect with Melissa (therapist) through the help of Honey. . . . After being able to open up, Melissa was then able to talk to my child about emotions, behaviors, and choices because of the work they were doing with Honey. Melissa and Leah (Little Bit staff) were able to role play and demonstrate how my child's behavior could affect another person. My child also got to watch Honey engage with other horses and how their behavior affected each other. My child got to understand emotions and was able to tell how Honey was feeling and that Honey felt sad when my child's session was over. This showed my child how to use the tools Melissa taught them on how to be a friend and how to care for others. . . . My child is now able to process their emotions AND they have the tools because of EFP. I wish that every child had a chance to do EFP. . . ."*

## Other Programs

In addition to Little Bit Therapeutic Riding Center's primary programs including Therapy, Adaptive Riding, Equine-Facilitated Psychotherapy, and Equine-Assisted Learning, the following programs are also offered:

### Annual Horse Shows

Sadly, all horse shows in 2020 were cancelled due to the COVID-19 pandemic. The Pat Flynn Memorial Horse Show is the culmination of a year's worth of progress in Therapy and Adaptive Riding and a celebration of abilities rather than disabilities. The Margo O'Callaghan Memorial Dressage Show provides a venue for riders of all skill levels to compete alongside their peers and be judged on their performance alone, regardless of ability or disability. We look forward to hosting hundreds of horse show participants and their family members in 2021 and beyond.

### Summer Camps

Camp experiences are open to individuals with or without disabilities and include riding lessons from PATH-certified therapeutic riding instructors, assisting with grooming and tacking horses, unmounted activities with horses, games, and much more. In 2020, our outdoor environment and numerous COVID-related safety protocols in place allowed Little Bit to welcome 40 unduplicated summer campers onsite and seven to our first-ever virtual summer camp.

### Inspiration and Education

Little Bit Therapeutic Riding Center serves as an inspiration and educational resource to the therapeutic riding profession, both regionally and nationally. In a typical year, we accomplish this by offering clinics, seminars, and training classes throughout the year, to both Little Bit staff and volunteers as well as individuals from other therapeutic riding organizations and those wanting to gain qualifications to enter the therapeutic riding profession. All onsite clinics, seminars, and training classes planned for 2020 were cancelled, except for one held in February, due to the COVID-19 pandemic.

Little Bit also offers **Unmounted Horsemanship Classes.**

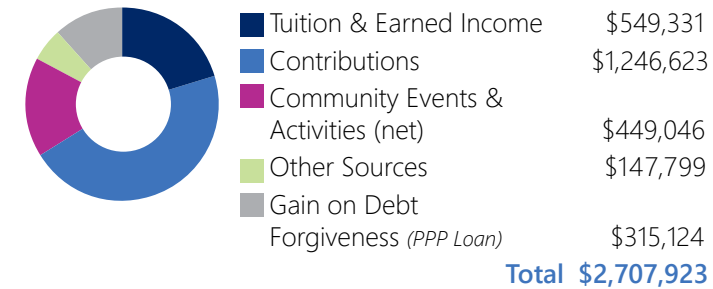

at December 31, 2020

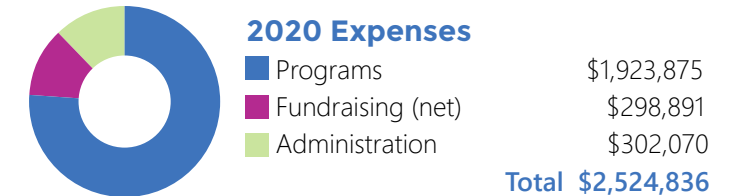

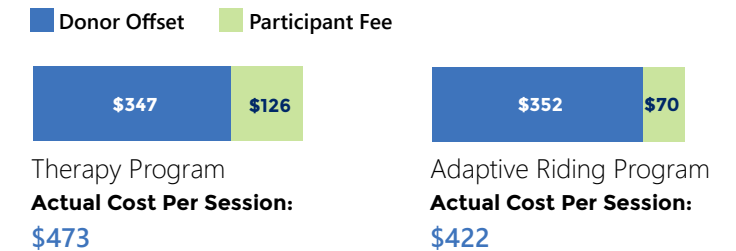
