LITTLE BIT HAS THREE MAIN PROGRAMS: THERAPY UTILIZING EQUINE MOVEMENT, ADAPTIVE RIDING, AND EQUINE-FACILITATED PSYCHOTHERAPY AND EQUINE-ASSISTED LEARNING.

ALL OTHER SCHEDULED WORKSHOPS AND CERTIFICATIONS WERE CANCELED IN 2021 DUE TO COVID-19.
